The meeting was called to order by President Tom Nate at 2:00 p.m. February 15, 2017.

<u>**DETERMINE IF CANDIDATES ARE UNOPPOSED:**</u> Ernie DeWinne announced that there werenøt any other resumes except from the two candidates that are up for reelections; Harry Maxwell and Ernie DeWinne and are declared unopposed.

SELECT AN INDEPENDENT AUDITOR: Ernie advised that since the candidates were unopposed no independent auditor will be needed.

Ernie advised that the Lelandøs approved the forest green paint for the storage tank and pressure tank and would like to see the building painted the same brown as the mail centers.
